PETITION FOR JOINT OR IDENTICAL POLE LOCATIONS

North Andover, Massachusetts

To The City Council
Of Amesbury, Massachusetts

Massachusetts Electric Company d/b/a NATIONAL GRID and Verizon New England, Inc requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Winkley Street - National Grid to install 1 JO pole on Winkley Street beginning at a point approximately 75 feet East of the centerline of the intersection of Hillside Avenue and Winkley Street. National Grid to install one new mid-span pole (#7) for future cable riser on Winkley Street, Amesbury, MA.

Location approximately as shown on plan attached.

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked – Winkley Street - Amesbury, Massachusetts.

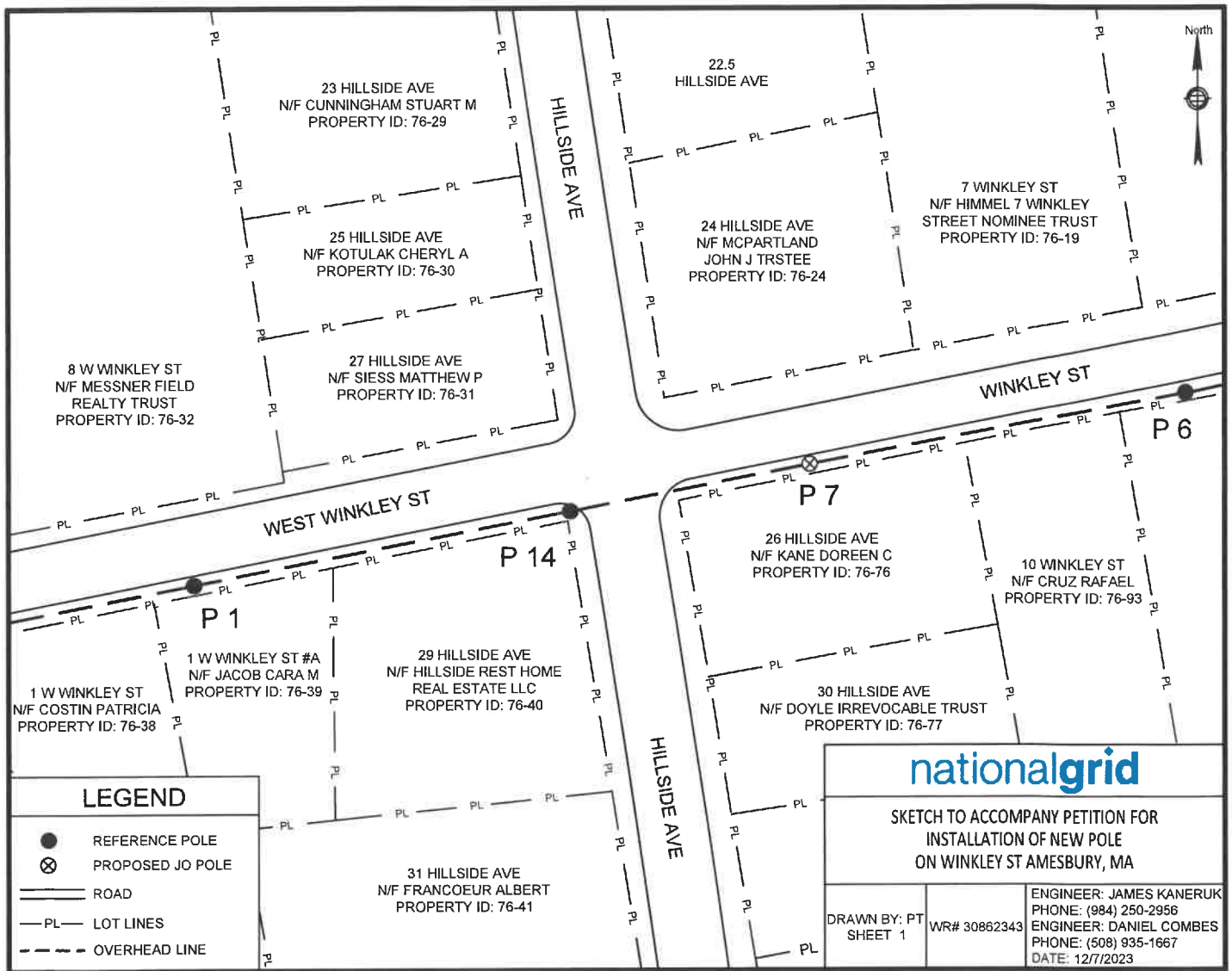

ORDER FOR JOINT OR IDENTICAL POLE LOCATIONS

To the City Council of - Amesbury, Massachusetts

Notice having been given and public hearing held, as provided by law,
IT IS HEREBY ORDERED: that Massachusetts Electric Company d/b/a NATIONAL GRID and VERIZON NEW ENGLAND INC. (formerly known as NEW ENGLAND TELEPHONE AND TELEGRAPH COMPANY) be and they are hereby granted joint or identical locations for and permission to erect and maintain poles and wires to be placed thereon, together with such sustaining and protecting fixtures as said Companies may deem necessary, in the public way or ways hereinafter referred to, as requested in petition of said Companies dated the 30th day of January, 2024.

All construction under this order shall be in accordance with the following conditions:

Poles shall be of sound timber, and reasonable straight, and shall be set substantially at the points indicated upon the plan marked – Winkley Street - Amesbury, Massachusetts.

Filed with this order:

There may be attached to said poles by Massachusetts Electric Company d/b/a NATIONAL GRID and Verizon New England Inc. such wires, cables, and fixtures as needed in their business and all of said wires and cables shall be placed at a height of not less than twenty (20) feet from the ground.

The following are the public ways or part of ways along which the poles above referred to may be erected, and the number of poles which may be erected thereon under this order:

Winkley Street - National Grid to install 1 JO pole on Winkley Street beginning at a point approximately 75 feet East of the centerline of the intersection of Hillside Avenue and Winkley Street. National Grid to install one new mid-span pole (#7) for future cable riser on Winkley Street, Amesbury, MA.

Also, for permission to lay and maintain underground laterals, cables, and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each of said petitioners may desire for distributing purposes.

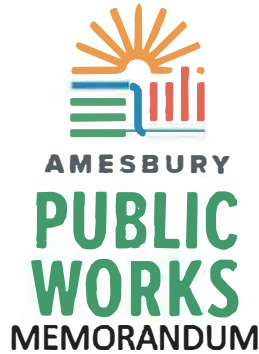

Amesbury Public Works has reviewed the proposed Pole Installation requested by National Grid and Verizon for Winkley Street in Amesbury on the Petition Plan WR# 30862343 dated February 4, 2025 and received by the City on February 11, 2025.

Public Works has no significant concerns with the installation of the pole. Public Works says pole must be installed in either the grass strip, (be cautious with granite curb,) or back of sidewalk. National Grid and Verizon confirm that the proposed installation does not conflict with other utilities within the edge of the City right of way prior to installation.

Public Work's review was completed to address the City's concerns of possible underground utility conflicts. This review was not intended to provide any indication that the property owners abutting the proposed pole location have no concerns with the pole.

Prior to installation or relocation of any utility pole, DIGSAFE, the City of Amesbury Department of Public Works, and the City Water and Sewer Departments shall be informed of the proposed activities.
